Welcome and Introductions

Strong Families Presentation and FLC Video opportunity – Ivonne calls on Kathie Valencia to share some brief reflections on the Strong Families project. Kathie thanked the FLC Partners for all their contributions to the Strong Families programming and explained how FLC Partners can step over to Meeting Room B to provide a comment for the FLC overview video.

A good mix of leaders participated in the video recording. There will be several leaders who could not be present that Ghostlight Creative will schedule for another recording opportunity.

Youth Sequential Intercept Model –Josue Lachica shared the steps leading up to the Youth Sequential Intercept Model event scheduled for October 25th and 26th. FLC Partners are invited to participate in this important day and a half planning session.

Work Group Development Progress Report – Enrique and Josue provided a brief presentation summarizing the August work group meetings. They explained that the work groups are developing and recognized that some may be renamed to align better with the goals and new strategies as developed by the work group participants. Ivonne Tapia and Cathy Gaytan elaborated on the meetings where they were present. The Group discussed next steps for October Work Group meetings.

Texas Tech Health Sciences Center El Paso CPAN/TCHATT Project –Jillian Longway, and Adrianne Harrel provided a progress overview of data from the start of the project to current. The group had the opportunity to ask questions about the programs and their success in connecting real time with patients and providers.

Help Me Grow Initiative - Gilda Gil and Laura Marquez shared their progress in development of the HMG initiative. They highlighted work with champion pediatric practices and their work developing a resource referral system,



Family Leadership Council Roles:

Meetings scheduled once every other month for no more than 2 hours.

- Provide executive leadership for work groups and task forces
- Approve Council System Improvement Priorities
- Approve strategies, shared measures and progress indicators
- Assign work group or task force organizational representation (e.g., designate representatives/subject matter specialists)
- Identify areas in need of policy or practice improvement (e.g., organizational policy changes or state/national policy)



FLC Work Group and Task Force Roles:

Meetings scheduled as needed

- Collaborate or coordinate to maximize resources
- Identify existing community groups or organizations implementing programs to assure positive synergy
- Work with representation at all levels within the system of care to implement approved strategies
- Coordinate with funders and technical support advisors



Work Group Progress Highlights – Opportunity for Change

- Primary Care: Expand and Enhance Integrated and Collaborative
 Care models for mental healthcare and related support access in the
 pediatric and primary care settings.
- <u>Crisis Care:</u> Expand and Enhance Existing or Develop a non-forensic cross agency mobile crisis team model to respond to a range of urgent needs outside the normal delivery of care.
- <u>Specialty Care:</u> Reframe the concept of mental health and substance use specialty care as secondary to Integrated Primary Care (e.g., 25% of care).

Work Group Progress Highlights – Opportunity for Change

- Recovery Care: Improve integration of acute inpatient care within the broader health system continuum of care (e.g., appropriate, and well-coordinated transition care and support from inpatient to outpatient to Integrated Primary Care settings).
- <u>Emotional Well-being</u>: Expand and enhance programs that promote emotional well-being, nurturing environments, and prevention of adverse childhood experiences.
- <u>Workforce Capacity:</u> Increase availability of evidence-based and promising practices (e.g., TI-CBT, PCIT, Capacitarl.

Progress Highlights

- Each work group identified additional organization representatives that need to be invited to participate.
- Primary Care, Specialty Care and Recovery Care work groups identified a need for specific definitions for key terms
- Each work group will meet again in October
- Work group leads are targeted to be confirmed in October
- Work group lead roles:
 - Establish the meeting agenda
 - Present or designate a presenter to report at the FLC General Meeting
