





(Since February of 2024, to Today 10/15/24)

Attendees seeking CEUs can expect to spend between \$15 and \$30 per credit hour, with LC3 estimating total savings for its members to be around an estimated \$12,525 to \$25,050 based on minimum state averages. Additional metrics and data will be gathered throughout the year.


