


LC3 HOUSING ACTION TEAM

Housing Services Action Team-LTG Objective:

Within the next 18-24 months, create a comprehensive, accessible, and user-friendly resource spreadsheet listing essential services for residents, including maps and location details. The resource will cater to both new and existing residents, focusing on supporting community integration and access to housing and other vital services.

- Types of Housing (e.g., affordable housing, transitional housing, emergency shelters)
- Food Resources (e.g., food pantries, community kitchens)
- Healthcare (e.g., clinics, mental health services, substance use support)
- Legal Aid (e.g., legal counseling, tenant rights)
- Employment Resources (e.g., job training, career counseling)
- Transportation Services (e.g., public transit, ride-sharing programs)
- Emergency Services (e.g., hotlines, disaster relief)


LC3 LEGISLATIVE AND SUSTAINABLE FUNDING ACTION TEAM


LEGISLATIVE AND SUSTAINABLE FUNDING ACTION TEAM
