

# Realize Las Cruces





A RECENT REPORT FROM PEW CHARITABLE TRUSTS STATES THAT "FROM OCTOBER 2017 TO OCTOBER 2024, MEDIAN RENTS IN NEW MEXICO INCREASED BY 60% WHILE THE COST OF A HOME CLIMBED BY 70%.

OUR CURRENT LAND USE AND ZONING REGULATIONS ARE ALMOST HALF A CENTURY OLD AND THEY HAVE CONTRIBUTED TO OUR HOUSING SHORTAGE AND HIGH HOUSING COSTS. PASSING REALIZE LAS CRUCES WILL GREATLY EXPAND HOUSING OPTIONS FOR OUR DIVERSE COMMUNITY, AND EASE THE BURDENS OF THOSE IN NEED OF A PLACE TO LIVE.



# Gary Housepian (He/His) Chief Executive Officer (Disability Rights NM)

Gary Housepian has been an attorney for more than 47 years. He has devoted those years to providing quality legal services to underserved populations - low-income people and persons with disabilities. That experience has embraced various roles - as legal advisor, litigator and manager. He is the CEO of Disability Rights of New Mexico since April 2018. Prior to coming to New Mexico, he was Executive Director of Legal Aid Society of Middle Tennessee and the Cumberlands, the largest public interest law firm in Tennessee for 10 years. He has held positions as General Counsel for the Tennessee Department of Mental Health and Intellectual Disabilities, General Counsel for the Tennessee Department of Human Services, Assistant Attorney General for the State of Tennessee, Managing Attorney of Disability Rights of Tennessee and Staff Attorney with Tennessee Justice Center. As a lawyer, he served as lead counsel in a class action settlement in Tennessee for persons with intellectual disabilities on waiting list for Medicaid Waiver services and participated in numerous health care class action cases in federal courts.

# 2025 Priorities

- To focus our work, DRNM currently advocates in 11 "priority areas" that impact people with disabilities, such as Housing, Special Education, and more.

# Decreasing Abuse, Neglect and Exploitation of Persons with Disabilities

### We achieve this by:

- Routine monitoring of facilities where people with disabilities receive treatment.
- Conducting patient rights trainings inside facilities.
- Conducting investigations where there allegations of abuse, neglect, or exploitation.

# Improving the Quality and Adequacy of Home and Community-Based Services



 Assure that community programs provide services that meet the need of individuals qualifying for or receiving those services.

# Special Education

We advocate for students who need special education services, as well as students who qualify for 504 plans under the Vocational Rehabilitation Act.

### We do this by:


- Advocating in IEP meetings with parents and students.
- Attending 504 plan meetings.
- Filing administrative "state" complaints with the NM Public Education Department.
- Filing Office of Civil Rights complaints.
- Representing clients in due process hearings with the NMPED.





Advocacy with Vocational Rehab participants, such as clients who are working with DVR, Commission for the Blind, or the Independent Living Resource Centers

 advocate for services that assist people with disabilities in finding and maintaining meaningful employment.






#### **Mental Health Services**


Expand the rights of individuals to receive appropriate mental health services, both in residential and outpatient mental health facilities and programs.

- Assist and advocate for individuals in need of mental health services in cases where services are delayed, denied, or significantly reduced, or
- where the amount, duration, or scope of services offered is clearly inadequate,
- and where there is serious risk to the individual's health or safety, or a serious risk of hospitalization or placement in a residential treatment facility, or
- when there appears to be a violation of an individual's rights in a residential treatment facility; and pursue systemic remedies as appropriate.



# Mental Health

• Within the *Kevin S.* case, advocate for the rights of children with disabilities in state custody to appropriate, individualized, accessible, adequate, and coordinated medical, mental health, and behavioral health services in safe and stable placements that are the least restrictive and appropriate to their needs from the Children, Youth and Families Department and the Human Services Department.





## Promoting Self-Determination and Self-Advocacy

 Advance the rights of people with disabilities to have control over the decisions that affect their lives. Assist persons subject to guardianship, treatment guardianship, or the authority of a representative payee with;

- preventing or terminating the substitute decision-making arrangement, or
- with achieving a less restrictive substitute decision-making arrangement, in cases where the person does not meet legal criteria for the existing arrangement based on her/his capacity, or where the substitute decision-maker appears to be non-responsive or act in an arbitrary manner to the reasonable preferences of the person,
- Abuse her/his authority, or
- Fail to fulfill fiduciary or other legal responsibilities.





# Self-Determination

 Provide outreach, training, and technical assistance to individuals seeking to develop mental health advance directives, and engage in systemic advocacy to promote mental health advance directives and other supported decision-making models as less restrictive alternatives to substitute decision-making arrangements.



### **Public Policy**

Expand, support and utilize the capacity of DRNM as well as individuals and organizations in the disability community to influence public policies and systemic changes in policies, statutes and regulations affecting individuals with disabilities.

 Review and comment on proposed regulatory changes in Medicaid or other public programs that have a significant effect on eligibility, benefits, or procedural protections for persons with disabilities.

# DRNM Systemic Advocacy

- Lawsuit against NM Corrections Department to ensure that people who are incarcerated and have an opioid use disorder (OUD) are continued on their medication for opioid use disorder when they enter NMCD custody.
- Lawsuit of *M.G. v. Scrase filed* on behalf of all medically fragile children under the age of 21 who qualify to receive private duty nursing through the State's Medicaid program. The lawsuit against the New Mexico Human Services Department (HSD) and the three Managed Care Organizations (MCOs) for the continued failure to provide medically necessary in-home nursing and to monitor the provision of these services across the state.
